- 1. Biography of Nominee:** Please append the nominee's **full CCV** in a separate attachment. Free form CVs will not be accepted.
- 2. Letter of Support:** No more than two (2) letters of support (at a maximum of two (2) pages each) should be submitted. One letter must be provided by an individual or individuals from the nominee's institution and include a signature from the Office of the Dean. The second letter must come from outside the nominee's institution (preferably an international collaborator).

Note: The Letter of Support should supplement the information provided in the CCV and contextualize the nominee's achievements. The letter should also address the evaluation criteria considering the following shared priorities of ICRH and CCCS: collaboration, knowledge mobilization, capacity development, strengthening Indigenous health research, and enhancing equity, diversity and inclusion.

Please provide a short justification (max 250 words) for your selection:** Nominations will be assessed against the evaluation criteria listed below in the context of the following shared priorities of ICRH and CCCS: collaboration, knowledge mobilization, capacity development, strengthening Indigenous health research, and enhancing equity, diversity and inclusion. Please ensure you provide the appropriate details information in order for the review committee to assess the candidates accordingly.

Note: To facilitate an equitable review process, nominators are encouraged to emphasize the influence of the nominee's research [pillars](#) on its progression, or any other unique barriers specific to the individual or to the field of critical care sciences.

Additional Nomination Details:

- If duplicate nominations are received for a single Nominee, Sponsors may be contacted to collaborate on a single coordinated nomination.
- Scientists who have received an ICRH-administered Mid-Career Lecturer Award previously are not eligible for nomination.
- Nominations for highly competitive candidates not selected may be carried forward for consideration up to three (3) consecutive years from the original nomination year.
- Late nominations or nominations with missing / incorrect documents will be rejected.

Evaluation:

Nominations will be assessed against the following evaluation criteria:

1. Impact of nominee's research on critical care sciences both in Canada and internationally; extent to which the nominee has contributed significantly to the advancement of critical care sciences both in Canada and internationally (e.g., important/key research results or findings);
2. Relevance, application, and impact of nominee's research to clinical outcomes, new intellectual property (IP), or other important breakthroughs, innovations, and discoveries in the field of critical care sciences;
3. Demonstrated strength and reputation of the proposed nominee in the field of critical care sciences in Canada and internationally; and
4. Impact of the nominee's mentorship and training environment on the development of early career scientists and other highly qualified personnel in Canada and internationally.
